The (Name of the person/Applicant) Sri Balaji Educational and Charitable Public Trust, Pondicherry has applied for establishment of Dental College in the name of Indira Gandhi Institute of Dental Sciences at the campus of the Mahatma Gandhi Medical College and Research Institute, Pondicherry. On careful consideration of the proposal, the Government of Pondicherry has decided to issue an essentiality certificate to the applicant for the establishment of a Dental College with 100 seats.

It is certified that:

- (a) The applicant owns and manages a 500 bedded Hospital in the name of Mahatma Gandhi Medical College and Research Institute, Pondicherry, which was established in 2001.
- (b) The applicant owns and manages a 100 bedded Dental wing (40 beds are exclusively for Dental Surgery and 30 beds for medicine and 30 beds for general surgery) in the 'F' Block of Mahatma Gandhi Medical College and Research Institute, Pondicherry.
- (c) It is desirable to establish a Dental College in the public interest.
- (d) Establishment of Dental College at Pillaiyarkuppam, Pondicherry by Sri Balaji Educational and Charitable Public Trust, Pondicherry is feasible.
- (e) Minimum 30 OPD Dental Patients per day are available to begin with

There is only one Dental College with an annual intake of 40 students availa in this Union Territory. This is a Govt. aided institution run by a Society. Therefore in case the applicant fails to create infrastructure for the dental college as per Der Council of India norms and fresh admissions are stopped by the Dental Council India, the State Government shall not take over the responsibility of the stude already admitted in the College as there is no Govt. Dental college available.
